Giulio Enrico Sironi graduated with honours in Law in 1995 from the *Università Cattolica del Sacro Cuore* of Milan with a thesis in Intellectual Property Law on registration as a trade mark of personal names and portraits.

Admitted to the Bar of Milan since 2001 and admitted to practice before the Highest Courts and the Court of Cassation since 2013. Since 1995 he has worked at the law firm Vanzetti e Associati and has been a partner with the firm since 2004. He regularly deals with all fields of intellectual property, in particular trademarks and other distinctive signs, appellations of origin and geographical indications, designs and models, patents, trade secrets, and copyright. He has extensive experience both in litigation and non-contentious activities. He advises clients in negotiations and agreements (settlements, licenses and co-existence agreements) and also regularly provides out-of-court advice on IP matters.
